The undersigned:

1. abbywinters.com BV established in Amsterdam, The Netherlands, hereinafter: “AWBV”,

and

2. hereinafter: “the Model”:

AWBV and the Model together also referred to as **Parties**;

taking into consideration that:

- (a) AWBV is an adult entertainment company.
- (b) AWBV produces sexually explicit images and video (“the Work”) by obtaining the services of models.
- (c) The Work can include, but is not limited to, audio, writing, video and still images.
- (d) AWBV will distribute the Work.
- (e) Models shall be paid a fee for their contribution to the Work, based on a schedule, as agreed at the Information Session the Model attends, before Booking.
- (f) Parties wish to enter into an occasional Modeling Contract and to set the conditions thereof as follows;
- (g) the Parties explicitly declare that they do not - in any way - wish to enter into an employment agreement;

Article 1: Model release

1. By signing this Release, the Model gives to AWBV her permission to license the images and / or video material and to use them in any media or for any purpose which may include advertising, promotion, marketing and packaging for any product or service (including but not limited to web, affiliates, DVD, VOD, poster, book, magazine). The Model understands and agrees that the material may be modified or altered.
2. The Model agrees that she has no rights to the Work and that all rights belong to AWBV. The Model subsequently agrees that she has no rights to future additional consideration or modeling fee or remuneration and that the Model will refrain from making any future claims. Both parties agree that this release is irrevocable.
3. The Work, once this Contract has been signed, and payment has been made in full, shall be owned by AWBV, and shall not be removed or redacted, under any circumstances, from any medium.
4. AW BV will represent the model under a pseudonym that AW BV selects, in all published images and video material. The model may choose to override this name selection and use their own real name if they prefer.
5. For the removal of any doubt, any prior conversations, representations implied or express, are superseded by this Contract.

Article 2: Modeling fee

1. The Modeling fee shall be paid by AWBV on the next banking day after the shoot, to the Model for the Work carried out. Payment shall not be due until after completion of the Work, the completion of this Release and associated documentation, and the furnishing of appropriate identification that AWBV will make a digital copy of.
2. The total Modeling fee for this work is indicated below (to be agreed when the Work is completed, in line with the Schedule discussed at the Information Session).

Article 3: Applicable law and disputes

1. If one or more provisions of the Release are deemed to be void by a Dutch court of law, such provisions shall be severed, and the remaining provisions of the Release remain in full force and effect.
2. Dutch Law is applicable to this Release. Any disputes emanating directly or indirectly from this Release fall within the exclusive jurisdiction of the Amsterdam Dutch Courts.
